Trading Suspended on Shares of Listed Companies

Based on the Securities Commission's letter No. 10/1505 dated August 13, 2026, due to non-compliance with financial disclosure requirements and failure to submit final accounts for 2025, the following decisions have been made:

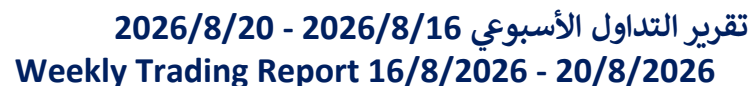
